Detailed, tamper-proof archive logs record archive access, search history, and specific data access, etc. After receiving a legal discovery request, legal case managers can create a new case and designate specific reviewers and custodians for each case. System administrators can also configure email monitoring and randomly sampled compliance reports for legal governance. When required, end-users can be assigned for separate data review tasks. Legal counsel can track the review process and completion of delegated tasks in real time to address requests quickly.

Implemented on premise, in the cloud, or in service providers’ datacenters, MessageSolution’s granularly controlled access permissions allow for custodial data access while keeping data access on a need-to-know basis.
