Case Resolution

Background

Louisiana School for the Deaf's history dates back to 1852, when the school taught just 11 students. Having provided rich educational experiences to deaf and hard-of-hearing students for more than 150 years, the school has grown significantly and faces many challenges in providing 24-hour support for students five days a week. Louisiana School for the Deaf (LSD) used Novell GroupWise Server for its 400+ email users.
